Background

The sponsor of a new Stanfield–Echo has designated that zone for areas that had formerly been inside an enterprise zone that terminated June 30, 2019. See table below for further details.

Zone Sponsor	Cities of Echo and Stanfield and Umatilla County, with consent by the Port of Umatilla
Area	The zone consists of 4.4 square miles encompassing all land inside the cities' urban growth boundaries.
Economics & Other	 The zone is well represented by census tract 9513 in Umatilla County, which has a per capita income that is 72% of the state's, according to the U.S. Census, American Community Survey 2014–2018 estimates. The zone sponsor's meeting for consultation with local
	taxing districts was well attended and appears to have entertained good discussion.
	• Echo and Stanfield had historically been part of the original Hermiston Area Enterprise Zone, and then the Greater Umatilla Enterprise Zone for 22 years. Disagreement between the City and County of Umatilla caused that city to seek re-designation on its own last year. Since then, the two cities here ultimately decided seek a new designation for themselves.
	 This designation is the 74th enterprise zone statewide, 57th rural zone, and 5th in Umatilla County.
	 Date of county resolution (as the last adopted) sets effective date of designation.

Statement of Salient Zone Features

Under ORS 285C.065 (2019), a city, port or county may designate an enterprise zone, subject to positive determination by the Oregon Business Development Department. The City of Echo, City of Stanfield and Umatilla County have sponsored such a designation and submitted documentation to that effect in accordance with agency administrative rules and the requirements of Oregon Law. Therefore:

- 1. January 22, 2020, is the effective date for designation of the Stanfield–Echo Enterprise Zone, I.
- 2. The newly designated rural enterprise zone is described in the attached materials and in agency records.
- 3. The Stanfield–Echo Enterprise Zone Enterprise Zone terminates June 30, 2025, under ORS 285C.255, the revision of which would cause the zone to terminate at the latest by operation of law on June 30, 2030.

Stanfield-Echo Enterprise Zone Boundary Legal Description

Beginning at Northeast corner of Section 30, Township 4 North, Range 29; thence West along the North line of said Section 30 to Northwest corner of said Section; thence South along the West line of said Section 30 a distance of 3,115 feet; thence South to the Northwest corner of the East Half of the Southeast Quarter of the Southwest Quarter of the Southwest Quarter of said Section 30; thence South and westerly to a point on the Union Pacific Railroad Company rightof-way station 165+79, thence southwesterly along said right-of-way to the East line of Section 31, Township 4 North, Range 29; thence South along the East line of said Section 31, 50 feet to centerline of said Railroad Company right-of-way; then northwest along the centerline of said Railroad Company right-of-way line to a point on the westerly extended South line of County Road No. 1331 (Hoosier Road); thence West along the South line of the extended County Road No. 1331 to the Northwest corner of the East Half of the Southwest Quarter of Section 31, Township 4 North, Range 29; thence South along the East line of the East Half of the Southwest Ouarter of said Section 31 to the Umatilla River; thence following said River to the East line of said Section 31; thence continuing along said North line of the river to the South line of Seymour Street platted in the Town of Foster, Book "I" Page 382 of the Umatilla County Deed Records (1883) and later recorded in Book 5, Page 10 of the Umatilla County Town Plats (1918) and the East bank of the Umatilla River as it existed in March, 1999; thence southeasterly along the East bank of the Umatilla River on the following courses: South 51°19'11" East, 14.05 feet to a 5/8" iron rebar; thence South 59°17'41" East, 111.97 feet to a 5/8" iron rebar; thence South 61°37'45" East, 106.51 feet to a 5/8" iron rebar; thence South 65°33'34" East, 65.69 feet to a 5/8" iron rebar marking the intersection of said East bank of the Umatilla River as it existed in March 1999, and the southerly line of Gordon Street (now vacated by Ord. No. 138, recorded in Book 253, Page 527, Umatilla Deed Records) as platted in the Town of Foster; thence North 48°45'00" East, 142.41 feet along the South line of said vacated Gordon Street to a 5/8" iron rebar marking the northwest corner of Block 12 (now vacated by said Ord.
